

# Thank you for the opportunity to propose a partnership with your organization! Here are some items to help define this potential relationship.

Started in 2009 by Josh Spurlock, MyCounselor provides online therapy to individuals, couples, and families and it also partners with organizations, like yours, to provide professional Christian counseling to people referred by you. MyCounselor has a few distinctives that are important for an organization partner like you.

- 1. Our therapeutic model is **based on the Bible**. Unlike some Christian counseling where scripture or prayer might be layered on top of the conversation, MyCounselor therapists have been trained in the biblical model of how God created humans, created their nervous systems, and what the Bible says about people and trauma. Because we start with the Bible, people experiencing counseling with a MyCounselor therapist will receive theologically sound advice from therapists who love Jesus, love the church, and understand the crucial role of the church in God's redemptive and transformational plan.
- 2. Our therapeutic model is also based on the most recent learning about **neuroscience and trauma**. Unlike traditional therapy that seeks to help the individual learn skills to cope with trauma, MyCounselor therapists have been trained to help the individual seek to resolve the trauma, giving the individual the potential for true healing.
- 3. Our therapists are **clinically supervised**. Many practices consist of a collection of therapists under one organization, but each therapist practices their own version of Christian counseling and from their own theological viewpoint. MyCounselor therapists spend their first 2,000 hours of therapy having their work reviewed by a supervisor, and another 1,000 hours of training before they become Certified therapists with MyCounselor. In order to become a therapist with MyCounselor, a therapist must have a masters degree in mental health. In order to become a Certified therapist with MyCounselor, they must spend 18-24 months in training. We hire less than 2% of all applicants and invest years into their training.
- 4. **We love the local church** and want to help the local church by providing professional counseling. We come alongside churches to provide an additional resource of professional therapy.
- 5. MyCounselor provides therapy to **individuals, married couples, pre-marriage couples, families, and teens**. Our therapists have specialized training in marriage, depression, anxiety, addiction, sex, gender identity, and many other presenting issues a person might have. We use a matching meeting process to help an individual or couple get connected with the therapist who can help them the best.

### **Scholarship Structure**

This document is intended to support clarity in our engagement with each other. If you have questions or concerns about any aspect of it don't hesitate to contact us. Throughout we will use the first plural person (us, we, our) to refer to MyCounselor.Online and our foundation Partners For Strong Families and the second person (you, your) to refer to the church as the Partner.

#### Structure of Counseling Services

- We provide coaching and counseling services via a membership structure for mental and relational health. Monthly subscriptions include 2 meetings with a counselor per month and discounted pricing for additional meetings as needed. Thus, scholarships are structured for even numbers of sessions translating into "months" or 4-week cycles of membership. (i.e. a scholarship for 3 months of membership, totaling 6 sessions).
- Session credits roll over month-to-month and are valid for 12 months following the ending of membership.
- Scholarships are for a percentage (i.e. 80%) of the total fees for a number of months (i.e. 3 months = 6 sessions).
- Additional sessions are the responsibility of the person/couple being referred unless specified otherwise by you.
- When scholarships end referred individuals/couples assume financial responsibility for their memberships.
- Counseling meetings canceled or rescheduled with less than 24 hour-notice incur a full fee charge for the time reserved.

#### Confidentiality

- Couples/individuals you scholarship will sign a 3<sup>rd</sup> Party Payer authorization to disclose billing information. This allows us to share with you billing details for financial accountability, including the start and end dates of membership, number of sessions attended, and other billing details as needed.
- The presenting issues and content of counseling meetings will not be shared with your organization without additional written consent from the client(s).

#### Fees

- Partner Membership costs are \$280 per month (includes 2 sessions), \$140 per additional session. There is a one-time assessment
   and setup fee of \$45. (i.e. 3 months scholarship (6 sessions) \$840 + \$45 setup fee, total cost \$885)
- Our planned fee increases occur every 2-3 years and are generally a 10-15% increase to adjust for inflation. Our last fee change occurred January of 2023.

#### Billing

- **A. ACH** With ACH billing your organization will provide ACH banking information and will be charged for covered transactions as they occur.
- **B. Credit Card** With Credit Card billing your organization will provide Credit Card information and will be charged for covered transactions as they occur plus a 3% service charge.
- **C. Check** For organizations requiring payment by check a retainer equal to the greater of 3 months anticipated usage or \$2,500 is required. The retainer will be charged for covered transactions as they occur and the organization will be billed monthly or at designated retainer level thresholds to replenish the retainer.

You can also refer individuals or couples to counseling with us simply by sending them the link to our website (<a href="https://mycounselor.online/">https://mycounselor.online/</a>) and having them click the "Get Matched" button. When they meet with our matching specialist, they need only mentioned they were referred by your organization and the terms of the scholarship (if any) they were offered. This referral path takes longer to schedule the person you refer as our matching team will need to reach out to the designated contact person for the organization to confirm the details of the scholarship before scheduling.
